## TOURNAMENT RULES AND REGULATIONS

1. The following rules plus USBC and TNBA rules will govern all participants of this tournament
2. This Tournament is open to all USBC & TNBA members. **Entrants must have both a USBC & TNBA card.** Any non-member of the USBC or TNBA may purchase membership prior bowling for: TNBA (\$26.00) or USBC (\$25.00). All cards must be presented at check-in; no temporary cards will be accepted unless purchased on site at the Tournament.
3. The reserve entry deadline is **March 10, 2019**. The full amount of fees must accompany the completed entry forms for the entry to be honored. Entries postmarked the 1<sup>ST</sup> business day following the entry closing date shall be accepted.
4. **PERSONAL CHECKS WILL NOT BE ACCEPTED FOR ANY REASON.** The total entry fee in the form of Money Order, Bank check or Certified check, must accompany the completed application.
5. This is a Handicap Mixed (Teams/Doubles) event with optional Singles.
6. All teams and doubles events must consist of at least one female and one male.
7. All teams must enter the Handicap division at \$120. If a team choose to enter the scratch divisions, then total fee would include an additional \$40. (\$160 for both divisions).
8. All bowlers participating in the doubles event must enter the Handicap division at \$60. If the bowlers choose to enter the scratch divisions, then total fee would include an additional \$20. (\$80 for both divisions).
9. Multiple entries are permitted for the mixed teams/doubles event, but not more than three (3) players on the same team may re-enter for the team event, and not more than one (1) player for the doubles event. Crossover doubles is part of the doubles event and can be re-enter once per squad.
10. All bowlers participating in the single event must enter the Handicap division at \$10. If the bowler choose to enter the scratch division, then the total fee would include and an additional \$10 (\$20 for both divisions). The bowler can enter the single event only once and the bowler's team event will count as the score for this event. (Based on the application) Men and Women divisions are separate.
11. Entry forms must show the full name (**no nicknames**), address, TNBA & USBC number and composite average of each bowler. Any omissions will delay processing until all information is received. If information is not received in a timely manner, the entry form may be returned.
12. Entrants must use their 2017-18 composite average listed on [Bowl.com](http://Bowl.com). In the event that a bowler does not have a 2017-18 composite average, then he/she must use the highest League average signed by the League/Senate President or Secretary. If none of the above, the bowler must enter the tournament with a 220 average. The USBC 10 pin average rule does not apply. USBC rule on Average adjustment may be applied to entering averages. **This is at the discretion of the tournament director.** All averages will be verified when applications are received, and again before payout.
13. It shall be each bowler's responsibility to verify the accuracy of his/her average, (whether originally submitted by the bowler, his/her team captain, or others.) **ALL AVERAGES FOR RESERVER ENTRIES MUST BE VERIFIED BY MARCH 10, 2019.** Failure to do so will result in disqualification. It is requested that the verification be sent with the tournament entry application. AVERAGE VERIFICATIONS can be in the form of: THE LOCAL ASSOCIATION MANAGER'S SIGNATURE, Senate President or Secretary, AN ASSOCIATION YEARBOOK, or the USBC PRINTOUT OF AVERAGES. If an entrant submits an average higher than his/her true average, he/she must live with the lesser handicap and no additional pins may be given to him/her. If an entrant submits an average less than his/her true average, he/she shall forfeit all prize money, and shall be disqualified, and subject to suspension from TNBA and USBC. **In order to avoid disqualification, entrants must make average corrections by the end of the first frame.**
14. Handicap for each game shall be 90% of 220. Handicap will be figured on an individual basis.
15. Substitutes shall be permitted at the discretion of the Team Captain and must bowl in the position of original entrant; **NO POSITION LINE-UP CHANGES WILL BE ALLOWED.** All rules and regulations likewise apply to substitutes. Once a substitute has started to bowl, the substitute must finish the event being bowled. **All substitute changes must be submitted by the Team Captain at least 30 minutes before scheduled squad time. NO EXCEPTIONS!!!**
16. The Tournament Director reserves the right to disqualify any entrant not in compliance with the rules of the tournament, TNBA, and USBC. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or there from, fire, natural disaster or any other reason beyond the control of the GATOR CITY SENATE, TNBA Tournament shall cause, to the extent required thereby, all prizes, to be prorated in accordance with the number of entrants who have bowled in each of the respective events up to the time of such termination.
17. Team Captains are requested to report to the Tournament Director's office for check-in of all team members at least one hour before time scheduled to bowl. The Team Captain must have all team members' USBC & TNBA cards at check-in. No individual check-ins will be allowed.
18. Events will be scheduled in the order names are listed on the entry blank. Tournament Director's time schedule will be final.
19. No player may change position in any team or doubles lineup after the entry has been scheduled. Violation will cause disqualification.
20. Tardy players will start in frame being bowled with zero being given for each frame missed. If a team refuses to start because a full line-up is not present, they shall receive zero for all frames which they decline to bowl. No blind score shall be permitted, and a bowler must bowl with and on the same lanes and at the same time his/her team bowls.
21. Provisional ball or frame will be used in situations where foul or legality of pin fall cannot be immediately resolved.
22. After entry has been received, no fees shall be refunded except in dire emergency such as strikes, lockouts, fires, etc., over which management has no control.
23. Prize fee will be returned 100% in the event for which it is collected. There will be at least one (1) prize for every nine (9) entries for both divisions (handicap & scratch).
24. Itemized entry fee per bowler: Handicap Division - \$30 per bowler (\$15 lineage & administrative fees/expenses; \$15 prize fund). Scratch Division - \$10 per bowler (\$4 administrative fees/expenses; \$6 prize fund). Single entry fee per bowler: Handicap Division - \$10 per bowler (\$4 lineage administrative fees/expenses; \$6 prize fund). Scratch Division - \$10 per bowler (\$4 administrative fees/expenses; \$6 prize fund)
25. PRIZE: Championships will be determined by the total pin fall plus handicap for the handicap division, and the total pin fall (no handicap) in the scratch division.
26. The decision of the Tournament Director shall be final on any and all disputes unless an appeal is made in accordance with rule 329.
